Smith. The types of moral values found in this film are honesty, authentic values, self-confidence, moral independence, humility, responsibility, tenacity, reality and crisis, moral conviction and courage. The second study from Nasir et al., (2019) conducted research on the analysis of moral values in the film Coco. The findings of this research indicate that there are nine types of moral values found in the film Coco, namely; honesty, courage, peace in ability, self-confidence and potential, loyalty and dependability, respect, love and compassion, selflessness and sensitivity, and finally, kindness and friendliness. The last study from Kurniati et al., (2022), They carried out studies to look at several moral principles and explain how these principles are portrayed in Harry Bradbeer's picture Enola Holmes. The movie includes multiple moral principles as described by Barrow (justice, respect

for individuals, freedom, welfare) and Haidt (care, justice or proportionality, freedom, authority or respect, and loyalty or in-group). In this movie, liberty or freedom is the most important moral principle.

The movie entitled *Ayla: The Daughter of War* is a Warner Bros.-produced drama genre film that was written and directed by Yigit Güralp and Can Ulkay. The tragic tale of South Korea's 1950 civil war serves as the basis for this movie. On September 11, 2018, this movie had its world premiere in a live screening at the Toronto International Film Festival. Just one month later, on October 27, 2018, the movie was released in Turkey, where it had its premiere. During its 2018 run, the movie garnered several awards, including the Richmond International Film Festival and the Cape Town International Film Market and Festival. Awards from the Palm Springs International Film Festival for Best Foreign Language Film and Best Asian World Film Festival were also given to the movie at World Fest Houston.

Furthermore, Turkey's movie *Ayla: The Daughter of War* received an Oscar nomination in the Best Foreign Language Film category for 2018 (Armaini & Masruroh, 2022). The film narrates the tale of the encounter between a Turkish ex-soldier named Suleyman and a South Korean young girl named Ayla. In addition to telling the historical account of Suleyman's travels, this movie also emphasizes politics, humanism, and a host of other topics. Additionally, this movie demonstrates cross-cultural communication. Other than that, there is a tragic plot that isn't always followed by happiness, and the plotline in this movie isn't always straightforward. This movie contains a lot of messages. This movie is based on the true story of the encounter between a litle South Korean girl named Ayla and a Turkish soldier named Suleyman. At that time, the Turkish soldiers and their group went through a woodland on their way to basecamp. They faced attacks there, but they resisted. Once they believed everything was secure, they patrolled through the woodland. Suleyman discovered a small child sitting calmly and sobbing amidst a heap of dead when he heard someone crying while on patrol. The litle girl is about five years old. Suleyman decided to bring the girl to base camp because he felt sad for seeing her. Suleyman ultimately made the decision to look after the child.

As long as the litle girl stay with Suleyman, she doesn't want to answer questions about her name. Until Suleyman eventually decided to give her a Turkish name, Ayla. It took Ayla a while to speak in Turkish, but eventually she called Suleyman "baba," or father. Suleyman was scheduled to return to Turkey at the end of his time of service, but he was not allowed to take Ayla with him until he eventually committed an unlawful act. He deside to take Ayla's into his bag with the express purpose of bring her to Turkey. Regretfully, Suleyman's coworkers found out about his acts. While Ayla was forced to live in his dormitory and attend a little school in Korea by soldiers, Suleyman was chastised until he eventually left Turkey alone. Suleyman to go.

In which the father vows to visit him again and never to leave this world before seeing his child (Cyntara & Rheisnayu, 2021; Wisesa, 2021)

Drawing from the justifications and explanations provided in the preceding section, the author is motivated to examine the moral values in the movie *Ayla: The Daughter of War*. The author hopes that this research will highlight the significance of moral values for readers and encourage them to always prioritize morals in life, since good morals will also have an impact on good behavior.


