This can be seen in the government system that upholds the sovereignty of the people and is oriented towards the ideals of the nation formulated in the preamble to the 1945 Constitution, namely protecting all the people and all of Indonesia's territory, advancing public welfare, and educating the nation's life and participating in implementing world order based on independence, eternal peace, and social justice. ### ABSTRACT

This thesis is entitled "Implementation of Regional Regulation No. 07 of 2013 Concerning Livestock Control in Central Bengkulu Regency" which aims to determine and describe the Implementation of Regional Regulations Concerning Livestock in Central Bengkulu Regency. This study uses a descriptive qualitative research method with the selection of 10 informants through purposive sampling techniques. There are 4 aspects discussed in this study, namely Socialization, Program Planning, Monitoring, Evaluation. The results of the study indicate that in terms of Socialization, it has been carried out by the Central Bengkulu Regency Civil Service Police Unit. The Program Planning aspect on facilities and infrastructure is still inadequate. The Monitoring Aspect carried out by the Central Bengkulu Regency Civil Service Police Unit is in the form of Patrol Supervision and Monitoring Evaluation Aspect There are still livestock farmers whose livestock roam agricultural land, on public roads that interfere with road users.

> strategies of the Indonesian government is the implementation of regional autonomy as a system that is expected to accelerate the development of the Republic of Indonesia's unitary regions effectively and efficiently. Regional autonomy provides an opportunity for each region to create regional regulations by prioritizing the needs and desires of the community.

> In Article 1 number (6) of Law Number 23 of 2014 concerning Regional Government, it is explained that regional autonomy is the right, authority, and obligation of autonomous regions to regulate and manage their own government affairs and the interests of the local



community. Where regional autonomy can be interpreted as the authority of autonomous regions to regulate and manage the interests of the community according to their own initiative based on the aspirations of the community, in accordance with laws and regulations. A regional regulation must not conflict with public interests and order. Order is one of the objectives of the formation of regional regulations and order is an atmosphere that is a dream in community life, and to realize all of that is not as easy as turning the palm of your hand. However, there must be a structured systematic effort made by the government, especially the Bengkulu Tengah Regency Government and assisted by community support.

Central Bengkulu is a Regency of Bengkulu Province. Its capital is Karang Tinggi District. This regency was formed based on Law Number 24 of 2008 which is a division of North Bengkulu Regency. In mid-2023, the population of Central Bengkulu Regency was 122,198 people with a density of 100 people/km and an area of Central Bengkulu Regency of 1,223.94km2. seen from the livestock population in Central Bengkulu Regency in 2022, it was 36,607. With details of the Beef Cattle Population of 13,829, Buffalo Population of 6,393, Horse Population of 14, Goat Population of 9,897, Sheep Population of 6,409 and Pig Population of 65.

The author found several problems regarding the implementation of the Bengkulu Tengah Regency Regional Regulation Number 07 of 2013 concerning the Order of Livestock. This can be proven by livestock that is Cows released without supervision so that it damages the garden land and the residents' yards so that there is a commotion among the villagers. Livestock that often roam freely are Buffalo, Cows and Goats. Farmers who do not have an understanding of order in livestock farming are considered as a source of problems from the implementation of order which is the subject of the author's research. ### **RESULTS AND DISCUSSION**

This research was conducted from November 2024 to December 2024. To collect data and information in this study, the author used purposive sampling technique.10 people who the author used as informants from the Service Police Unit Civil and the Community.informants based on the most dominant age group are those aged 41-50 years, namely 40%, then informants aged 30-40 who reached 30% and after that those aged 51-60 as many as 30%. The research activity conducted by the author is to determine the Implementation of Regional Regulation No. 07 of 2013 concerning Livestock Control in Central Bengkulu Regency. The tool used by the author is an interview guideline, which is designed to be able to lead the author to get answers from informants both from the Community and from Civil Service Police Unit Employees of Central Bengkulu Regency. In this study there are 4 aspects that the author examines, namely, Socialization, Planning Program, Monitoring and Evaluation.

Socialization of regional regulations regarding livestock is an important aspect in the management of natural resources and community welfare. The importance of socialization of regional regulations regarding livestock cannot be separated from the need to increase public awareness of their responsibility towards the animals they keep. The Socialization aspect is generally good and the Socialization of Regional Regulation No. 07 of 2013 concerning livestock control has been carried out 4 times in 2023 which was organized by the Bengkulu Tengah Regency Civil Service Police Unit.

Program Planning Aspect Planning a livestock control program is an important strategic step to maintain public order and public tranquility. In this context, the role of Satpol PP (Civil Service Police Unit) is very crucial because they are responsible for enforcing regional regulations related to livestock control. Satpol PP personnel have the main task of supervising and enforcing regulations regarding livestock maintenance. In terms of facilities and infrastructure must be improved, This includes facilities and tools needed in carrying out tasks. There must be a decent place to accommodate livestock that violate the rules before being moved to another location. Animal Handling Equipment, Tools such as temporary cages, transport vehicles, and medical equipment must be available to handle emergency situations.

Monitoring Aspect Monitoring of regional regulations regarding livestock control is an important aspect in maintaining public order and tranquility. Satpol PP (Civil Service Police Unit) has a central role in the implementation and enforcement of laws related to these regional regulations. In this context, it is important to understand the extent to which Satpol PP carries out its duties in monitoring and enforcing existing regulations. The purpose of monitoring is to evaluate the effectiveness of Satpol PP in monitoring regional regulations related to livestock. This includes an analysis of





existing policies, implementation in the field, and challenges faced by Satpol PP. compliance from livestock owners regarding legal awareness is still lacking. This includes the lack of supporting facilities such as official vehicles for mobilization to remote locations.

Overall, Satpol PP has monitored regional regulations related to livestock control, but there are still various challenges that need to be overcome so that the implementation is more effective. Evaluation Aspect The implementation of the control of four-legged livestock maintenance in Central Bengkulu Regency shows several challenges and obstacles that need to be considered. Based on the research conducted, there are several aspects that are the focus of the evaluation. There are still farmers who let their livestock roam on public roads, which disturbs road users.

### CONCLUSION

Socialization in general has been good andThe socialization of Regional Regulation No. 07 of 2013 concerning livestock control has been carried out 4 times in 2023 which was organized by the Civil Service Police Unit of Bengkulu Tengah Regency. facilities and infrastructure are still inadequate.
